

IMPRACTICAL JOKERS CRUISE SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.

VOID WHERE PROHIBITED.

SPONSOR: Courtroom Television Network LLC d/b/a truTV, 1050 Techwood Drive, Atlanta, GA 30318 (“**Sponsor**”).

ADMINISTRATOR: Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165, an independent judging organization (“**Administrator**”).

By participating, you (“entrant” or “you”) agree to abide by and be bound by these official rules (“Official Rules”) and the decisions of Sponsor and Administrator, which are final and binding in all respects and not subject to appeal.

1. SWEEPSTAKES: Impractical Jokers Cruise Sweepstakes is a random draw sweepstakes (“**Sweepstakes**”) which begins at 7:00:00 PM Eastern Time (ET) on February 9, 2017 and ends at 11:59:59 PM ET on May 11, 2017 (the “**Sweepstakes Entry Period**”). The sole determinant of time for the purposes of receipt of a valid entry in the Sweepstakes will be the Sponsor’s clock.

2. ELIGIBILITY: The Sweepstakes is open only to persons ages 18 and older, and, as of the time of entry, are legal residents of, and physically located within, the 48 continental United States or D.C. **excluding Alaska and Hawaii** (collectively, “**Territory**”), and are not officers, directors, or employees of Sponsor, or Administrator; their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (collectively, the “**Sweepstakes Entities**”); nor members of their households or immediate families. The Sweepstakes is subject to all applicable federal, state, and local laws.

“Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. “Household members” shall mean people who share the same residence at least three (3) months a year, whether related or not.

3. HOW TO ENTER: Visit the entry website at TruTVSweeps.com (“**Website**”) to complete the entry form which includes your name, date of birth and email address (“**Address**”), and click the “Enter” button (“**Entry**”).

Limit one (1) Entry per person/Address/per day. If a dispute arises regarding who submitted an Entry, the Entry will be deemed to be submitted by the authorized account holder of the Address associated with the Entry. Authorized account holder is defined as the natural person who is assigned to an Address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted Address.

4. LIMITATIONS: Entrants who have not complied with these Official Rules are subject to disqualification and their Entries will be void. Sponsor reserves the right to disqualify any Entrant's registration in the Sweepstakes if Sponsor determines or suspects that the Entrant has attempted to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other fraudulent, deceptive, or unfair playing practices. Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes at any time if fraud, technical failures, or any other errors or other causes corrupt the administration, security, integrity, or proper play of the Sweepstakes. In the event of cancellation, Sponsor reserves the right to select the Winners from among all eligible Entries received up to the time of such cancellation, in a manner determined by Sponsor to be fair, appropriate, and consistent with these Official Rules.

The Sweepstakes Entities do not warrant that access to the Sweepstakes will be uninterrupted. Neither the Sweepstakes Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, "Releasees") are responsible for: (a) Entries from persons residing, or physically located, outside the Territory; (b) Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Official Rules; (c) lost, interrupted or unavailable networks, servers, satellites, websites, or other connection, availability, or accessibility problems arising in connection with or over the course of the Sweepstakes; (d) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other errors in connection with the administration of the Sweepstakes, the processing of mail or Entries, or the offering or announcement of the Prizes (defined in Section 5) or in any Prize notification documents; (e) any other errors of any kind relating to or in connection with the Sweepstakes, whether human, mechanical, clerical,

electronic, or technical in nature; (f) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Sweepstakes; (g) any changes to any Website function that may interfere with the Sweepstakes or your ability to timely enter; or (h) damage to a user's system occasioned by participation in this Sweepstakes or downloading any information necessary to participate in this Sweepstakes; even if caused by the negligence of any of the Releasees.

5. PRIZE AND APPROXIMATE RETAIL VALUE (“ARV”): One (1) grand prize (“**Grand Prize**” or “**Prize**”) will be awarded. Each Grand Prize Winner (“**Grand Prize Winner**” or “**Winner**”) will receive an *Impractical Jokers Cruise*® package to Costa Maya, departing on November 1, 2017, for winner and up to three (3) guests (together with the winner, the “Group”), consisting of a four (4) night cruise on the Norwegian Pearl (“**Ship**”) (the “**Trip**”). Trip consists of the following elements for the Group: **[a]** one (1) stateroom (quad occupancy) aboard Ship; **[b]** all onboard meals (with exception of specialty restaurants as listed on the *Impractical Jokers Cruise*® website); **[c]** pre-paid gratuities, Taxes, Fees and Port Expenses (as defined on the *Impractical Jokers Cruise*® website); **[d]** if winner’s residence is located more than two hundred (200) miles from New Orleans, LA, round-trip coach air transportation on a Sponsor-selected carrier between a Sponsor-selected major metropolitan airport near Winner’s residence (“**Airport of Origin**”) and Louis Armstrong New Orleans International Airport (or other airport at Sponsor’s discretion), but if winner’s residence is located two hundred (200) miles or less from New Orleans, LA, round-trip ground transportation will not be provided, however, Port of New Orleans (“**Port**”) parking for one (1) personal vehicle is covered; there is no compensation for mileage driven or reimbursement for fuel or a rented vehicle, and **[e]** airport/Port transfers if air transportation is provided. Additional restrictions and/or inclusions regarding the Trip may apply. Approximate retail value (“**ARV**”) of Grand Prize is \$3,500, which will vary depending upon Airport of Origin and destination and seasonal fluctuation of cruise and airfare rates at the time Trip is booked. All benefits are personal to the winner and are not redeemable for cash and neither is assignable nor transferrable.

Group must travel from November 1, 2017 – November 5, 2017 (subject to change at the sole discretion of Sponsor). If travel is not completed on the required dates the Prize will be forfeited and Releasees will have no further obligation to such winner. Group must travel together on the same Trip and must travel from the same Airport of Origin.

All members of the Group will be required to execute and return a Release of Liability prior to participation. Members of the Group are responsible for providing proper citizenship documentation to travel which may include passports, valid alien registration card and/or necessary visas. Those without proper citizenship documentation will be denied boarding. Winner is responsible for ensuring that members of the Group have proper citizenship documentation. If any of the Winner's travel companions are a minor, the Winner or one of the other members of the Group must be such minor's parent or legal guardian and accompany such minor in the same room.

All expenses not specifically mentioned herein are not included and are solely the Winner's responsibility, including but not limited to: round trip transportation between the Winner's residence and any Airport of Origin, activities and ground transportation not expressly included in the Trip, alcoholic beverages, excess luggage fees, customs and immigration fees, passport costs, travel protection insurance, laundry service, merchandise, parking, room service, service charges, souvenirs, spa services, ship to shore communications (including internet), shore excursions, nursery charges, and other optional activities, telephone calls and some additional gratuities and taxes which are not expressly included in the Trip. Photo identification and credit card or cash deposit may be required at check-in for incidental charges. Trip components are subject to change without notice. Any depiction of the Trip is for illustrative purposes only and may not reflect actual Prize won. Any difference between ARV and actual value will not be awarded. Winner is responsible for any transportation not specifically noted in these Rules. Certain restrictions, as determined by Sponsor, may apply. If the Group cannot comply with these restrictions or any portion of these Rules, the Prize will be forfeited in its entirety and an alternate Winner may be chosen. Travel arrangements must be made through Sponsor's agent and on a carrier of Sponsor's choice. If Group cannot travel on the dates specified by Sponsor, the Prize will be forfeited in its entirety and the Prize may be awarded to an alternate Winner selected in a random drawing from among all remaining eligible entries. Travel dates and flight details will be subject to availability. All airline tickets are subject to the vagaries of flight variation, work stoppages, and schedule or route changes. The Trip may not be combined with any other offer, and travel may not qualify for frequent flier miles, award points or other perquisites. None of the Releasees are responsible for lost or mutilated tickets and none will be replaced. Airline tickets are non-refundable, non-transferable, and are not valid for upgrades. The accommodations and airline tickets will be determined at the sole discretion

of Sponsor. If any portion of the Prize is not available for any reason then the Sponsor reserves the right to substitute that portion of the Prize with another prize of comparable or greater value. Travel must be round trip. If Winner elects to take the Trip without guests or fewer guests than provided, components of the Trip will be awarded in increments/quantities suitable for the actual number of travelers and Winner will not receive any compensation or substitute/alternate prize for same. Any portion of the Trip not accepted by Winner will be forfeited. Trip and Trip components may not be sold, traded, transferred, rescheduled to dates not within the fulfillment period set forth above, or refunded. Other travel and accommodation restrictions, conditions and limitations may apply. Airline carrier's and Ship's regulations and conditions apply.

Winner will be responsible for all federal, state and local taxes associated with the Prize, including without limitation, providing any and all tax documents such as an IRS Form W-9. Winner will receive an IRS Form 1099-MISC reflecting the final actual value of his/her Prize. Prize will be awarded provided a sufficient number of eligible Entries are received, and Prize is validly claimed by July 31, 2017, after which no alternate Winners will be selected, nor unclaimed Prize awarded.

6. PROCEDURES AND ODDS OF WINNING: Odds of winning a Prize depend on the total number of eligible entries received during the Sweepstakes Entry Period. Sponsor will select the potential Winner in a random drawing on or about May 18, 2017 ("**Drawing Date**") from among all eligible entries received.

7. HOW TO CLAIM PRIZE: The potential Winner is subject to verification and participant's full compliance with these Official Rules before any Prize will be awarded. On or about two (2) business days following the random drawing, the potential Winner will be notified via email to confirm a mailing address as well as any additional required information or responses. Once the potential Winner's mailing address is received, the potential Winner may be sent paperwork by overnight delivery service or via email to the Address provided during Entry. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Winner (if time permits) may result from any of the following: (a) a potential Winner's failure to respond to email notification within two (2) business days after transmission; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notification as undeliverable; (d) a potential Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency, if required; (e) a potential Winner's failure to provide

Administrator with satisfactory proof that he/she is the authorized account holder of the email address associated with the winning Entry, if required; (f) a potential Winner's failure to provide any required additional information upon Administrator's request; (g) a potential Winner's failure to execute and return an Affidavit of Eligibility, a Liability Release ("Affidavit") within five (5) business days after its mailing; and/or (h) any other non-compliance with these Official Rules. In the event of any Prize forfeiture by a potential Winner, the Sponsor may, in its sole discretion, award or not award the forfeited Prize to an alternate Winner.

8. PRIVACY POLICY: Personal information provided by you in connection with this Sweepstakes is subject to Sponsor's privacy policy located at <http://www.trutv.com/copyright/index.html>. If you are selected as the Winner, your information may also be included in a publicly available Winners list.

9. RELEASES: By participating in this Sweepstakes, you agree: (a) to release, indemnify, and hold harmless the Sweepstakes Entities from any and all liability, loss, or damage incurred with respect to participating in the Sweepstakes or the awarding, receipt, possession, and/or use or misuse of a Prize; (b) that under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, any punitive, indirect, incidental, consequential, exemplary, or any other damages, other than for actual out-of-pocket expenses; (c) all causes of action arising out of or connected with this Sweepstakes or the awarded Prize shall be resolved individually, without resort to any form of class action; (d) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, and in no event will Entrants be entitled to receive attorneys' fees or court costs. Winner, by acceptance of a Prize, grants to Sponsor, the other Sweepstakes Entities, and each of their respective designees the absolute right and license to use, publish, post, and/or display his/her name, address (city and state of residence), photograph, voice, likeness, and/or other indicia of persona (regardless of whether altered, changed, modified, edited, used alone, or used with other material in the Sweepstakes Entities' sole discretion) in any and all media now known or hereafter devised, throughout the world, in perpetuity, without additional compensation or consideration, notification or permission, unless prohibited by law.

Sweepstakes details contained in these Official Rules and Sweepstakes details contained in Sweepstakes-related materials, these Official Rules shall prevail. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The Sweepstakes Entities' employees are not authorized to waive, modify, or amend any provision or provisions of these Official Rules in any manner whatsoever. **ANY ATTEMPT BY AN ENTRANT OR OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES IS A VIOLATION OF LAW.
