

YOUR FAVORITE TRUTV SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.

VOID WHERE PROHIBITED.

SPONSOR: Courtroom Television Network LLC d/b/a truTV, 1050 Techwood Drive, Atlanta, GA 30318 (“Sponsor”).

ADMINISTRATOR: Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165, an independent judging organization (“Administrator”).

By participating, you (“entrant” or “you”) agree to abide by and be bound by these official rules (“Official Rules”) and the decisions of Sponsor and Administrator, which are final and binding in all respects and not subject to appeal.

1. SWEEPSTAKES: Your Favorite truTV Sweepstakes is a random draw sweepstakes that will consist of five (5) separate daily sweepstakes (collectively and individually “Sweepstakes”) which begin at 12:00:00 AM Eastern Time (ET) on September 11, 2017 and end at 11:59:59 PM ET on September 15, 2017 (the “Entry Period”). The sole determinant of time for the purposes of receipt of a valid entry in the Sweepstakes will be the Sponsor’s clock.

2. ELIGIBILITY: The Sweepstakes is open only to persons ages 21 and older, who are, as of the time of entry, legal residents of, and physically located within, the 48 continental United States or D.C. excluding Alaska and Hawaii (collectively, “Territory”), who have received an email regarding the Sweepstakes directly from a representative of Sponsor (“Sweepstakes Email”) and are not officers, directors, or employees of Sponsor, or Administrator; their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (collectively, the “Sweepstakes Entities”); nor members of their households or immediate families. “Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. “Household members” shall mean people who share the same residence at least three (3) months a year, whether related or not.

3. HOW TO ENTER: Internet access required. Sponsor will send one (1) Sweepstakes Email each day during the Entry Period, and each Sweepstakes Email will include a “button” that links to the www.trutvsweeps.com (“Website”) to enter the sweepstakes per the table below. By following the directions on this page and watching a clip from a truTV show, the Sweepstakes Email recipient will earn an entry into the applicable Daily Sweepstakes.

Limit one (1) Entry per person/Address per calendar day. If a dispute arises regarding who submitted an Entry, the Entry will be deemed to be submitted by the authorized account holder of the Address associated with the Entry. Authorized account holder is defined as the natural person who is assigned to an Address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted Address.

4. LIMITATIONS: Entrants who have not complied with these Official Rules are subject to disqualification and their Entries will be void. Sponsor reserves the right to disqualify any Entrant’s registration in the Sweepstakes if Sponsor determines or suspects that the Entrant has attempted to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other fraudulent, deceptive, or unfair playing practices. Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes at any time if fraud, technical failures, or any other errors or other causes corrupt the administration, security, integrity, or proper play of the Sweepstakes. In the event of cancellation, Sponsor reserves the right to select the Winners from among all eligible Entries received up to the time of such cancellation, in a manner determined by Sponsor to be fair, appropriate, and consistent with these Official Rules.

The Sweepstakes Entities do not warrant that access to the Sweepstakes will be uninterrupted. Neither the Sweepstakes Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, “Releasees”) are responsible for: (a) Entries

from persons residing, or physically located, outside the Territory; (b) Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Official Rules; (c) lost, interrupted or unavailable networks, servers, satellites, websites, or other connection, availability, or accessibility problems arising in connection with or over the course of the Sweepstakes; (d) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other errors in connection with the administration of the Sweepstakes, the processing of mail or Entries, or the offering or announcement of the Prizes (defined in Section 6) or in any Prize notification documents; (e) any other errors of any kind relating to or in connection with the Sweepstakes, whether human, mechanical, clerical, electronic, or technical in nature; (f) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Sweepstakes; (g) any changes to any Website function that may interfere with the Sweepstakes or your ability to timely enter; or (h) damage to a user's system occasioned by participation in this Sweepstakes or downloading any information necessary to participate in this Sweepstakes; even if caused by the negligence of any of the Releasees.

Total ARV of all prizes: \$10,914.00. **Limit one prize per person per Address.**

All federal, state, and local taxes (including income and withholding taxes), if any, as well as any other costs and expenses associated with Prize acceptance not specifically mentioned herein are not included and are solely Winner’s responsibility. Releasees are not responsible for the

At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Winner (if time permits) may result from any of the following: (a) a potential Winner's failure to respond to email notification within two (2) business days after transmission; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notification as undeliverable; (d) a potential Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency, if required; (e) a potential Winner's failure to provide Administrator with satisfactory proof that he/she is the authorized account holder of the email address associated with the winning Entry, if required; (f) a potential Winner's failure to provide any required additional information upon Administrator's request; (g) if required, a potential Winner's failure to execute and return an Affidavit of Eligibility, a Liability Release ("Affidavit") within five (5) business days after its mailing; and/or (h) any other non-

compliance with these Official Rules. In the event of any Prize forfeiture by a potential Winner, the Sponsor may, in its sole discretion, award or not award the forfeited Prize to an alternate Winner.

8. PRIVACY POLICY: Personal information provided by you in connection with this Sweepstakes is subject to Sponsor's privacy policy located at <http://www.trutv.com/copyright/index.html>. If you are selected as a Winner, your information may also be included in a publicly available Winners list.

RELEASES: By participating in this Sweepstakes, you agree: (a) to release, indemnify, and hold harmless the Sweepstakes Entities from any and all liability, loss, or damage incurred with respect to participating in the Sweepstakes or the awarding, receipt, possession, and/or use or misuse of a Prize; (b) that under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, any punitive, indirect, incidental, consequential, exemplary, or any other damages, other than for actual out-of-pocket expenses; (c) all causes of action arising out of or connected with this Sweepstakes or the awarded Prize shall be resolved individually, without resort to any form of class action; (d) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, and in no event will Entrants be entitled to receive attorneys' fees or court costs.
